Please enjoy the stories, data and photos in this review. If everyone who takes the time to read this learns just one thing about our Department and our City, we will have accomplished our goal.

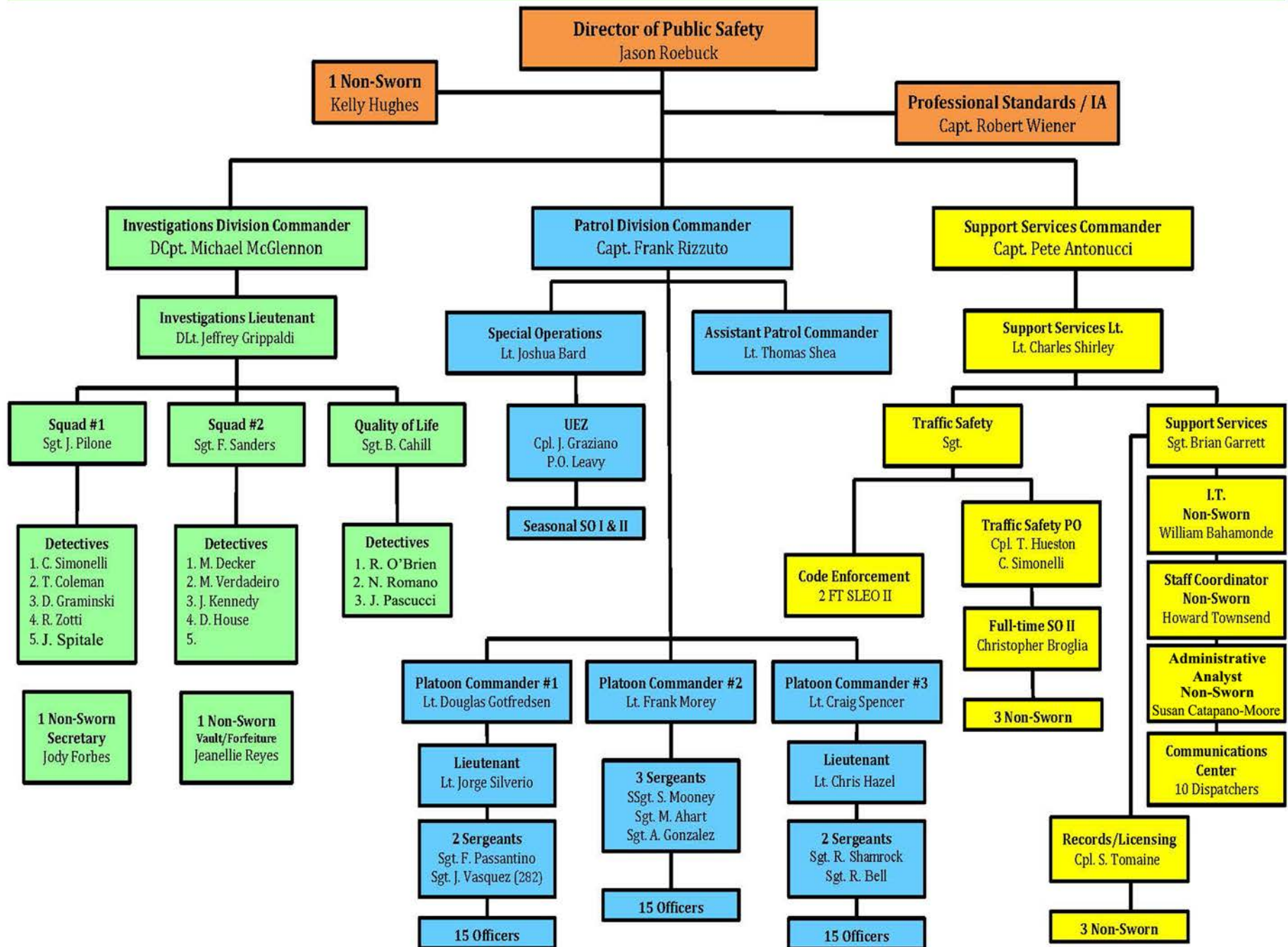

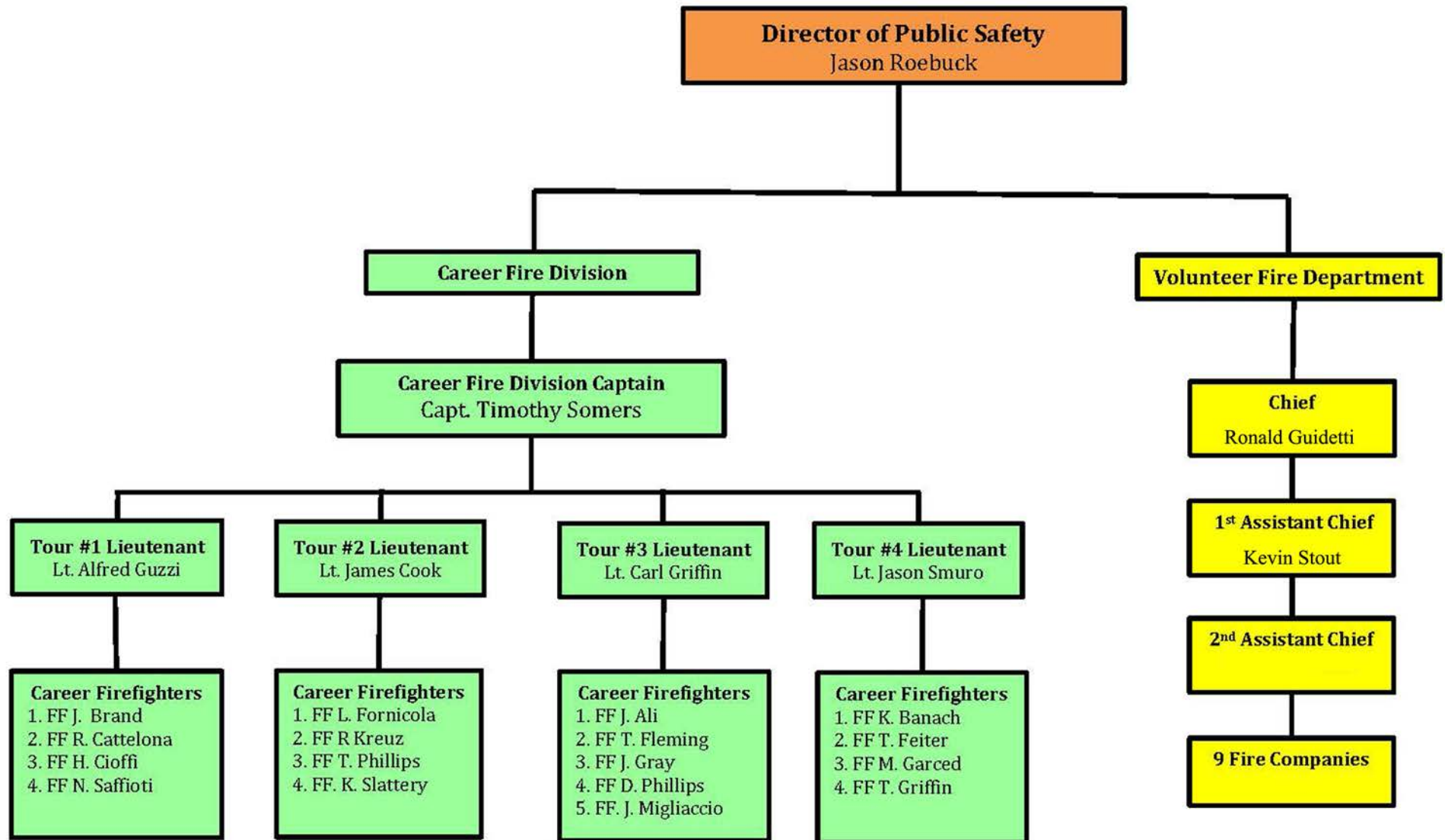

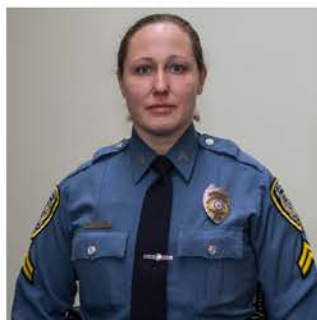

They were certified as an Explosives Detection K9 team, making them the first Explosive Detection K9 team for the LBDP. In addition, they attended the Long Branch/Tinton Falls Police K9 Patrol Class #1, graduating on 06/02/06 as a certified Patrol K9 team. MOTOR UNIT



Our Motorcycle Unit participates in year-round activities including escorts, funeral details and safety programs such as "Share The Road" and "Toys for Tots" runs. This year, the unit sends a special thanks out to Toys for Tots for presenting them with a plaque of appreciation and to our friends at Woolley-Boglioli Funeral Home for their very generous donation of heated hand grips. The grips will help to keep them warm during inclement weather and, inevitably help ensure their safety while riding.

HAZMAT TEAM

The Hazardous Materials Response Team (HAZMAT) is comprised of members from both the PD and the FD. The team responds as the mass decontamination unit in the event citizens are exposed to a hazardous material and provides specialized equipment to help clean off products that may contaminate individuals in an emergency. Members are seen here, along with Asbury Park members, participating in mandatory annual training drills.



In August, the Fire Department, Beach Lifeguards, Office of Emergency Management, First Aid and the U.S. Coast Guard-Manasquan participated in a multi-agency water rescue drill simulation at the Morris Avenue beach. The drill was an opportunity for all responding agencies to work together in a real-life, in-water operation that took place in real time. The scenario simulated a party boat exploding and sinking 300 yards off-shore. Lifeguards acted as victims in the water clinging to debris. Some acted as injured victims needing immediate rescue. The victims had to be removed from the water by Lifeguards and Firefighters. The Lifeguards deployed jet skis, boats and rescue boards, while the Firefighters deployed rescue boards. The Coast Guard provided scene safety, keeping away curious onlookers, and simulated the removal of a deceased victim. At the conclusion of the drill a team meeting was held, all lessons learned were discussed and a report detailing the drill was distributed to all involved. A future event is planned for next summer to keep our first responders at the top of their game. Photos were taken via drone.

WATER RESCUE TEAM





The Urban Enterprise Zone (U.E.Z.) is our Community Outreach Team. They are focused on maintaining the flow of information to our local businesses and the community. Corporals Joseph Graziano and Kimberly Leavy, members of the UEZ, play a major role in the development and implementation of the many programs and events throughout the city. They run City Hall/PD tours, give presentations to business owners, provide numerous school presentations about police and safety for our younger students, coordinate the annual Night Out, assist the fire department with fire safety presentations, participate in local organizations' events such as "Trunk Or Treat" and countless others. In addition, they are credited with creating our very successful Citizens Police Academy and Seniors' Police Academy, and recently became certified to perform car seat safety checks.





STREET CRIMES Unit

The Street Crimes Unit is a team comprised of one Commanding Officer and three Detectives. Their primary focus is to eliminate drug manufacturing and distribution within the City and reduce the availability of narcotics and other illegal substances to our citizens. In addition, they serve as an intelligence bureau for criminals involved with weapons, gangs and other illegal activity.

In 2016, the unit made 220 arrests. 133 arrests were narcotics related. Seized during those arrests were:

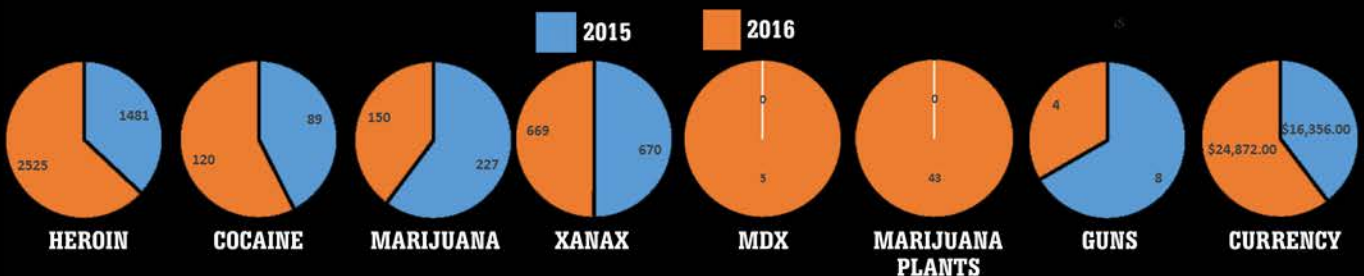
- 2,525 Decks of Heroin
- 120 grams of Cocaine
- 150 grams of Marijuana
 - 669 Xanax pills
- 5Lbs MDX- synthetic opioid
 - 43 Marijuana Plants
 - 4 Handguns
- \$24,872.00 US Currency

In 2015, the unit made 214 arrests. Seized during those arrests were:

- 1481 Decks of heroin
- 89 grams of Cocaine
- 1/2 Lb of Marijuana
 - 670 Xanax pills
 - 8 Guns
- \$16,356.00 US Currency

The Unit formed a Search Warrant Entry Team this past year which submitted 4 vehicles for forfeiture as well as drafted search warrants for 9 residences and 4 vehicles.

SEIZURE COMPARISONS 2015 & 2016

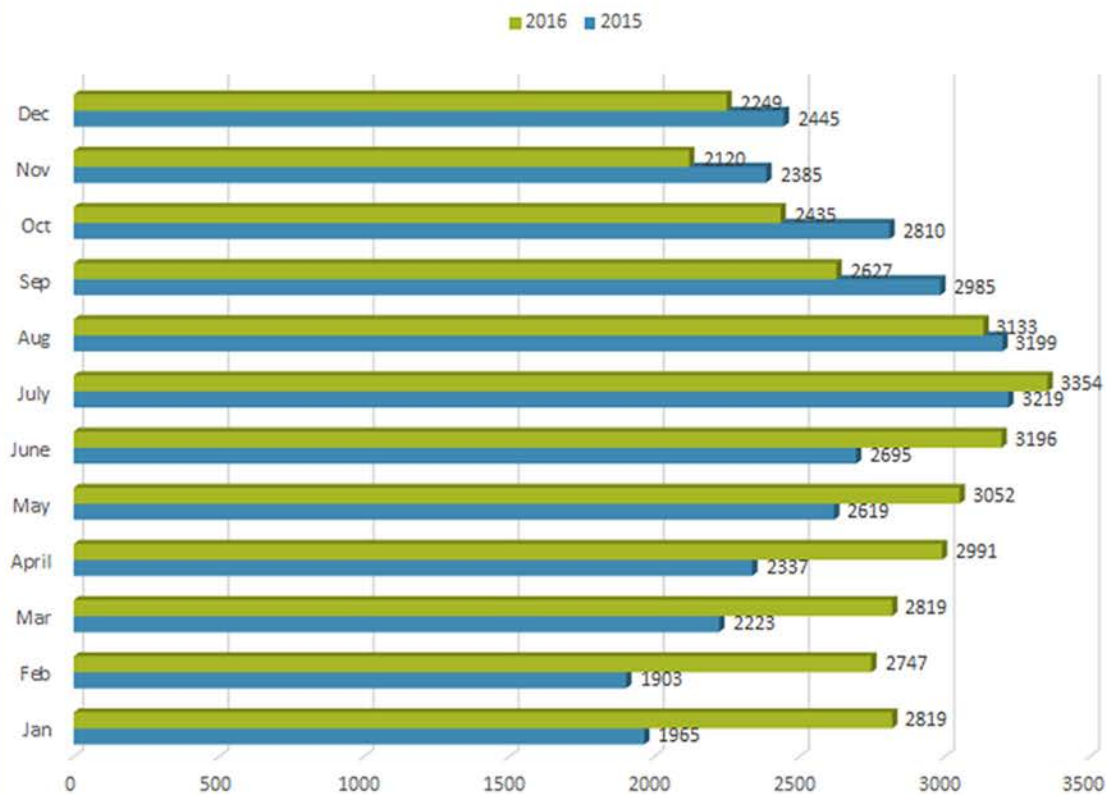


PATROL ZONES

Calls For Service Comparison 2015 & 2016

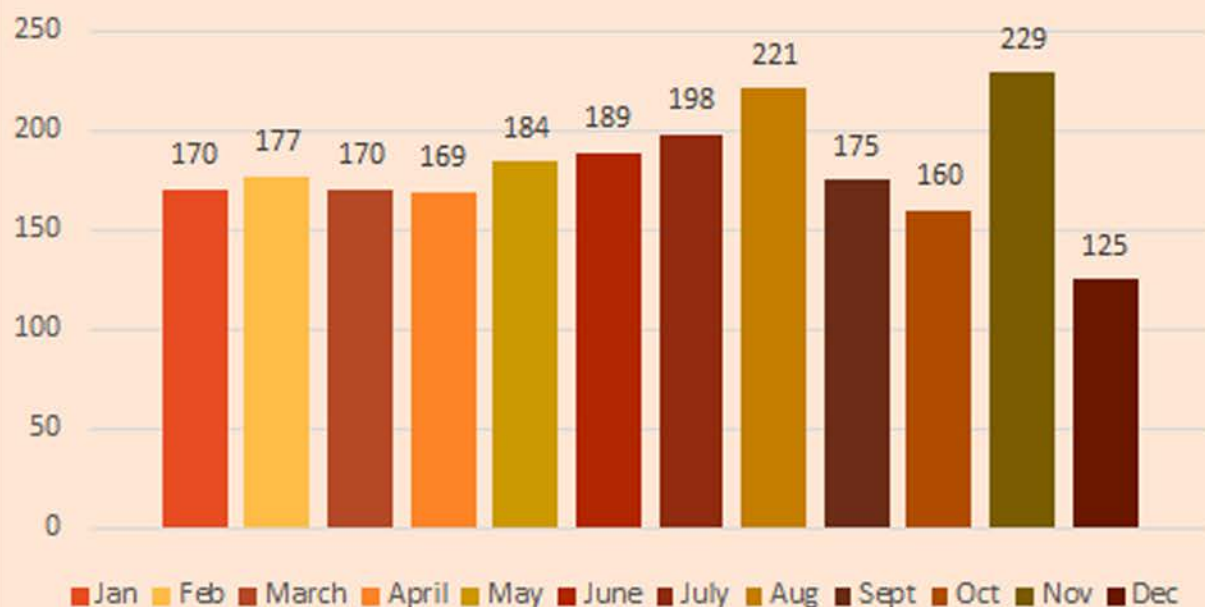


9-1-1 Call Comparison 2015 & 2016

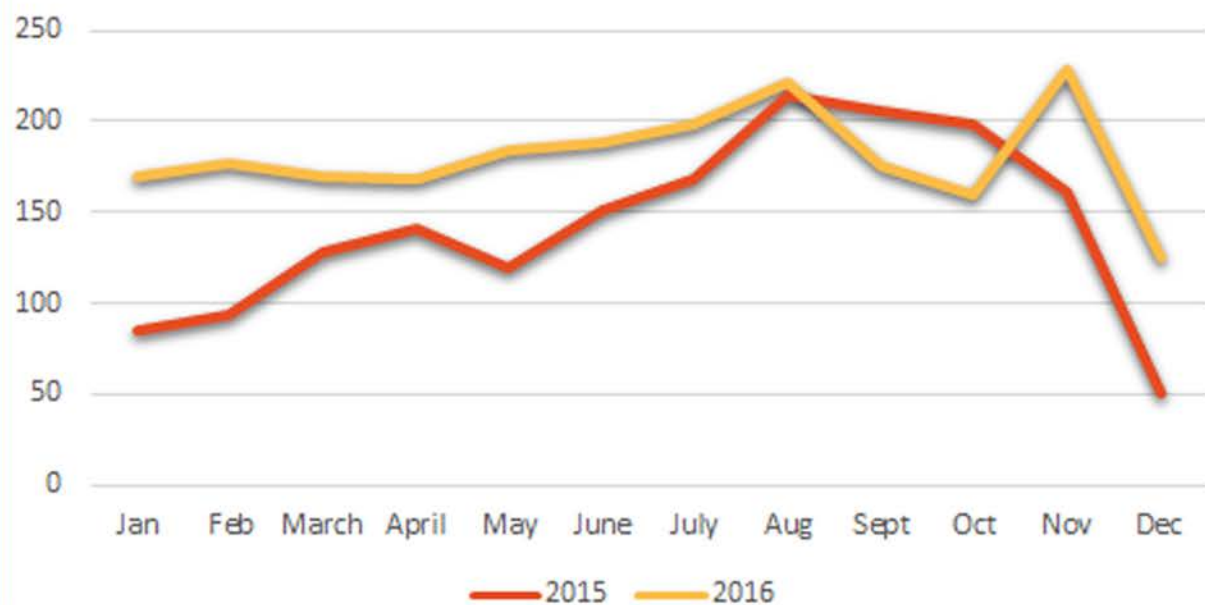

Arrests By Month for 2016

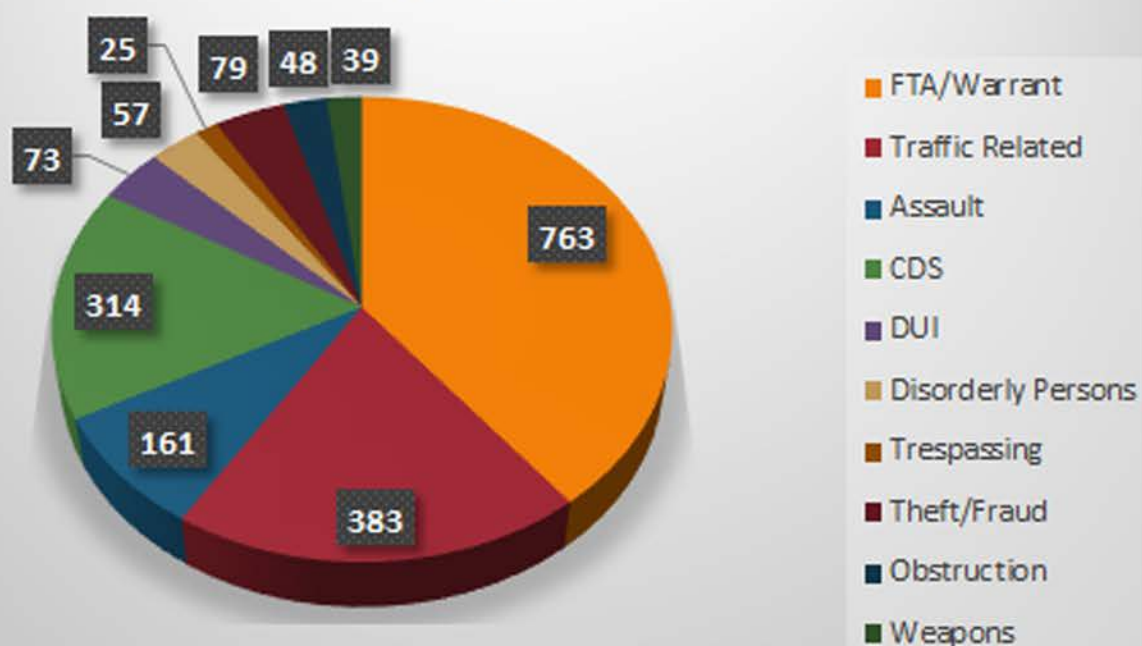


Monthly Arrest Comparison 2015 & 2016



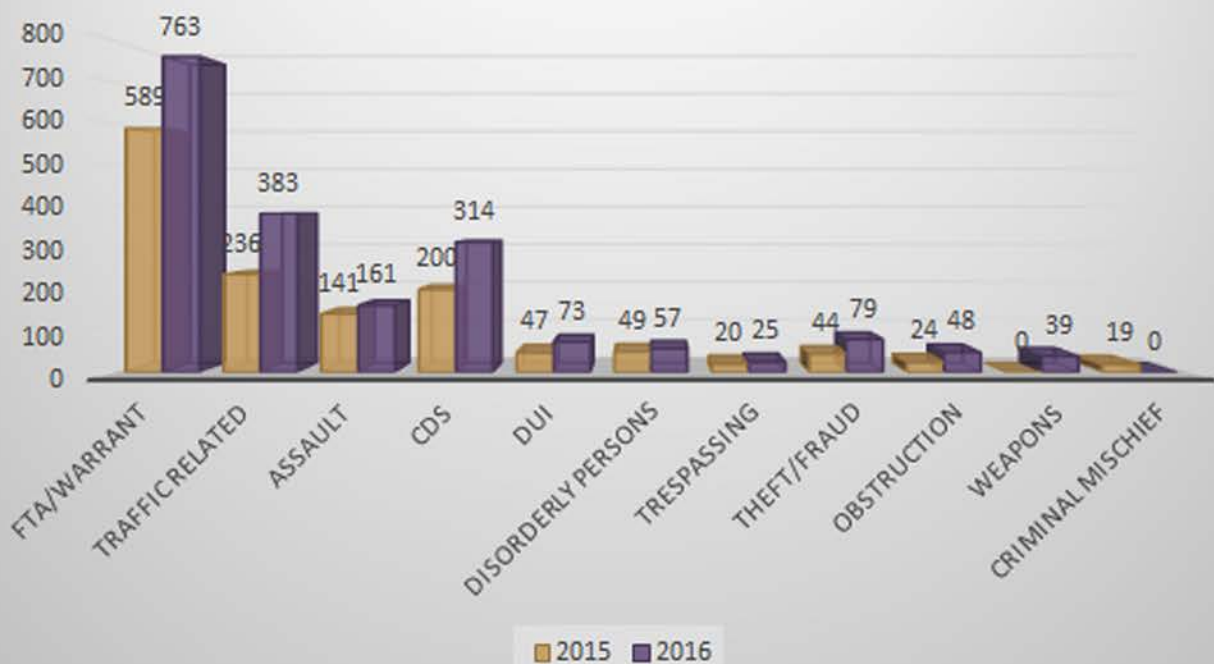
10 Most Common Arrest Charges for 2016

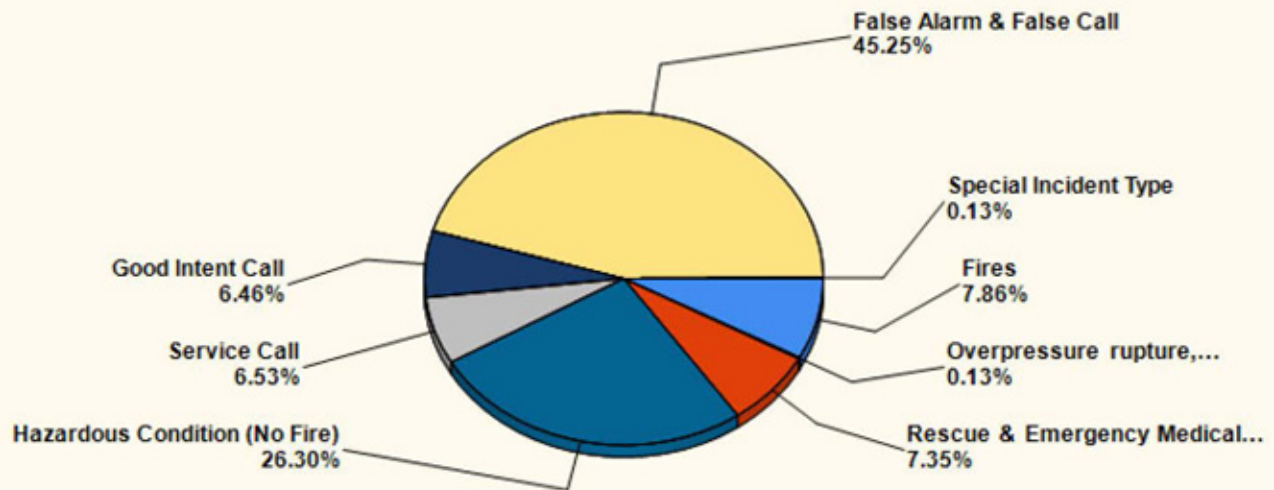
2015-2016 Comparison of 10 Most Common Arrest Charges

In April, the City Fire Department took delivery of two new fire apparatus. The pumpers were built by Pierce Manufacturing in Appleton, Wisconsin. Pierce is known for its quality in the fire service for over 100 years. The twin pumpers have 2000 gallon per minute pumps on board and have begun to help modernize our aging apparatus fleet. One of the units is stationed at Fire Headquarters on Union Avenue and will be operated by the city's career staff. The other unit is stationed at Neptune Hose Company on Branchport Avenue. Neptune Hose is one of the oldest volunteer companies in the City and this unit should provide them and the City with years of service.

The Department of Public Safety developed and implemented an evaluation system for all employees of the police and fire departments. The core evaluation consists of a trait-based assessment and there will be two evaluation periods per year. Supervisors will use the evaluation process as an opportunity to conduct career counseling relative to such topics as advancement, specialization, or what training may be appropriate based on the employee's position.

OFFICER TRAINING

Officers and Firemen are required to attend in-service training sessions to stay up-to-date on current laws, professional guidelines, operations and procedures. The sessions consist of classroom style instruction as well as hands-on training. Some of the training is department specific, while much of it is mandated by the county prosecutor, Attorney General and by state or federal statutes and rules. Most of the mandated training is required every six months to one year. A few topics covered in the training are firearms requalification, domestic violence, bloodborne pathogens, hazardous materials and breathalyzer recertification. In addition to in-service days, all specialized units conduct job-specific training and qualification sessions and officers are assigned to attend other agency training courses as needed. 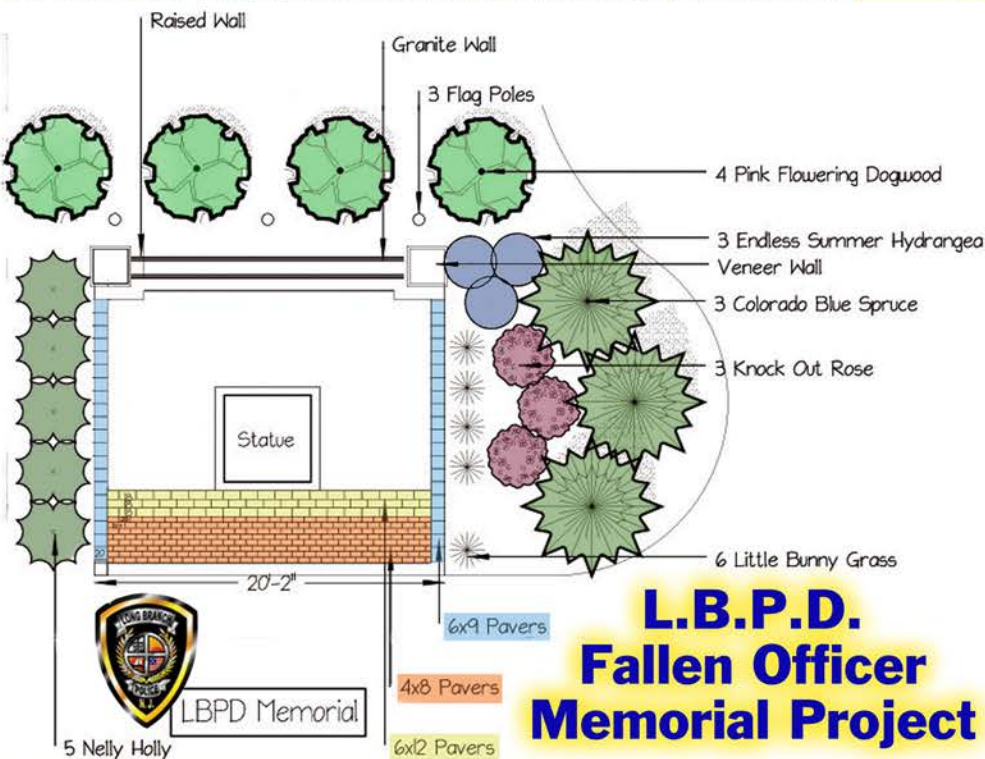
P.B.A. Fallen Officer Memorial Project

On 9/1/15 the FD responded to a structure fire that was upgraded to a possible entrapment while enroute. Upon arrival, A/Lt Slattery confirmed a working fire in a 2 1/2 story wood-frame occupied dwelling and asked for a 2nd alarm to be transmitted. Firefighters confirmed trapped occupants on the second floor and proceeded to the scene to join the search and rescue effort. The stairwell area was on fire with heavy smoke and heat conditions. The stairwell and landings were heavily soaked with a gasoline smelling liquid that made these conditions potentially very dangerous. A/Lt. Slattery found victim #1 and removed him via the stairwell. Chief Guidetti, with assistance from LBPD, placed a hand line in service to protect the stairwell while the rescues progressed. FF Phillips finished a search of the top floor, made his way down to the 2nd floor, and located victim #2 and removed him via the stairwell and side door. Chief Guidetti controlled the fire and stairwell with the handline until FF Banach advanced it and was then operating in the 2nd floor hallway. Phillips and Guidetti along with Lt Griffin began CPR on the child. FF Saffioti, low on air, located victim #3. and turned her over to Lt Cook and FF Banach who removed the victim down the stairwell. At this time, the fire was knocked down and a moderate smoke condition was effecting the 2nd floor. A/Lt. Slattery, who had re-entered the dwelling, notified Lt. Griffin that there was another victim unaccounted for. Lt. Griffin, FF Griffin and FF Cattelona began a secondary search and found victim #4 and removed him and administered CPR. It was later confirmed that a large amount of gasoline had been poured throughout the building. All members were aware that this accelerant posed an extremely hazardous condition to the lives of the victims and firefighters. In conducting these multiple rescues, initially without the protection of a hand line, the members placed themselves in an extreme situation and performed in the highest traditions of the fire service and the City of Long Branch Fire Department.

MERIT AWARD

Sgt. Frank Passantino

While off-duty and traveling home from a training course, Sgt. Frank Passantino was stopped at a traffic light and stumbled upon a road rage incident in progress. An individual, holding a baseball bat, ran towards an individual in another car's driver's window, yelling and swinging the bat. Sgt. Passantino drew his service weapon and ordered the subject to drop his weapon. He then ordered the man to the ground and called the Wall Police. He checked the well-being of the victim and kept custody of the suspect until local police arrived. The incident, which had started on Route 18, escalated with the suspect speeding up on Route 138, driving onto the curb and tossing coins at the victim's window. When they were forced to stop for the light at an intersection, the suspect ran from his car swinging his bat.

On February 16th, 2016 SGT Robert Shamrock responded to a call for service of loud noise at 36 Jackson Street. Upon his arrival he made his way up to the source of the noise in a second floor apartment. As he went up the steps, he heard the distinctive metallic sound of a rifle bolt being racked back and forth, and then heard voices discussing "doing a shooting". He continued up the stairs, and the door to the apartment was slightly open.

He was able to observe several subjects passing around a bolt action rifle and "racking" it. They were also discussing how not to leave prints on the rifle after using it in the shooting. Realizing he was out numbered, SGT Shamrock backed away to observe the activity and called for assistance. After a standoff, they were able to arrest all 4 individuals and locate various handguns and contraband in the residence.



Members of Long Branch FMBA Local #68 were honored by the New Jersey State Firefighters Mutual Benevolent Association at their 2016 Valor Awards Banquet. The Firemen listed below were awarded the Gold Medal of Valor for their performance during a structure fire on September 15, 2015. During that call, each of the officers showed tremendous bravery and professionalism in their search and rescue efforts. In spite of the extreme dangers of this structure fire, including the presence of an accelerant, these men were able to remove three trapped individuals, attempt CPR and re-enter the scene for the fourth. They later learned that gasoline was poured throughout the house and that all four victims had been shot in a murder-suicide.

In addition, intern positions are offered to local college students who plan to make public safety their career. Students accepted to the program spend several days along-side a Police Officer or Fireman to get a feel for real-life, day-to-day operations.





EXPLORERS POST #167

Police Explorers Post #167 invites young adults, ages of 14 – 20 years old to learn valuable skills, first-hand from officers. A few skills covered are Self Defense, Traffic Direction, Life-Guarding, EMS and Fire Fighting. Members are offered opportunities to volunteer as police assistants during local events, learning the basics of public safety, while making new friends in a positive environment. Events include Car Shows, Concerts, Parades, Oceanfest and other events both in the city and out-of-town. Post #167 promotes a Team effort in a productive environment and rewards members with trips to places like the Monmouth County Police Academy and even Great Adventure.



CITIZENS POLICE ACADEMIES

Citizens Police Academy #3 graduated in December. Developed and run by Cpl. Joseph Graziano and P.O. Run in cooperation with the Senior Center, the class was a huge success and really helped to address the concerns of our senior community.



SCHOOL PROGRAMS

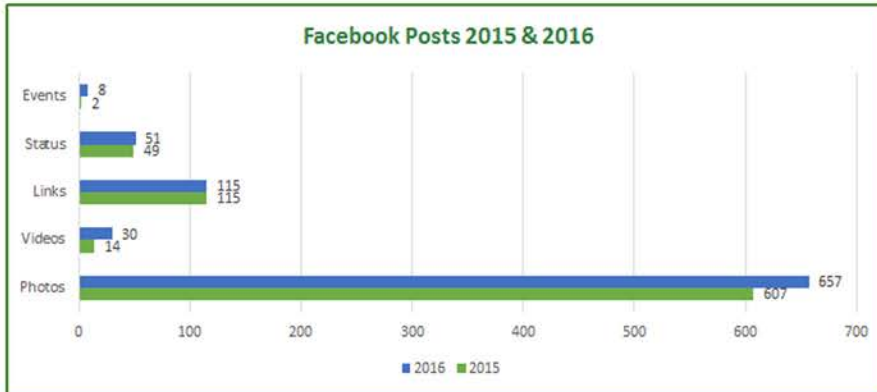


SUMMER PROGRAMS

NJ COP SHOT – ALERT

20k Reward offered in assault of Long Branch Police Officer
\$20,000 REWARD

The NJ Cop Shot program has posted a reward of \$20,000 dollars leading to the arrest and conviction of the suspects responsible for the assault of a Long Branch Police Officer early Tuesday morning. The officer was in uniform when he observed flashlights and movement within an abandoned property on the corner of Bath Avenue & Westwood Avenue, Long Branch. The officer approached the property and a foot pursuit ensued. The officer was found unconscious in the back of the property. The officer was rushed to an area hospital and is in stable condition suffering from head and neck injuries.

New Jersey State PBA President Patrick Colligan said, "Our thoughts and prayers are with this officer, his family, and all the officers within the Long Branch Police Department during this difficult time. In an effort to capture anyone responsible for the assault of this officer, the State PBA is offering a \$20,000 reward through the NJ COP SHOT program for information leading to the arrest and conviction of anyone responsible for this assault on a police officer."

The NJ State PBA is asking anyone with information to call Crime Stoppers of Monmouth County at 1-800-671-400 or to text "TIPCOP" plus your tip to 274637 (CRIMES). NJ Cop Shot is a program run by the New Jersey State PBA.

PRESS RELEASES

On March 31st 2016, at approximately 0600 hours, Lt. Jorge Silverio was patrolling in the area of Myrtle Avenue when he recognized a stolen vehicle being operated by a subject later identified as Dwayne Williams. After a short vehicle pursuit, Williams crashed into a parked vehicle and fled on foot, discarding a handgun and black mask. A perimeter was set up and Long Branch PD K9 handler, Sgt. Robert Shamrock and Monmouth County Sheriff's Officer K9 handler, Kurt Kroeper performed a track for the suspect. Further investigation revealed that a subject matching Williams' description called for a cab from a nearby location, McDonald's in West Long Branch, and took that cab to Wanamassa. L.B.P.D's Detective Bureau was on scene by this time and Detectives Lt. Jeff Grippaldi, Sgt. Jeff Pilone, Joseph Spitale, Todd Coleman, Michael Verdadeiro, Ross Zotti and Joe Kennedy went to that location, near Wanamassa Gardens. With the assistance of Ocean Township PD and Lt. Segarra, Detective Lt. Torchia, Detectives Malone and Burke, they were able to locate Williams hiding in the attic of a nearby apartment complex.

For several months, Williams had been a person of interest in a string of armed home invasions and burglaries in the Brazilian community. Because of the cooperation between the Long Branch Detective Bureau and the Patrol Division, and with the assistance of the Ocean Township Police, Williams was ultimately charged with several of these burglaries and home-invasion style robberies.

Williams was charged with multiple counts of burglary, robbery, possession of a weapon, possession for unlawful purpose, aggravated sexual contact, theft, eluding, resisting arrest and obstruction for crimes within Long Branch. He was wanted on a violation of probation for possession of a weapon. Judge Joseph Oxley set Williams' bail on the above charges at \$400,000 cash only with no 10% option. Williams was also charged in Ocean Township for hindering his own apprehension and resisting arrest. Judge Sonnenblick set bail on these charges at \$20,000.00 with no 10% option. Williams is 26 years old with a last known address of Allen Ave in Ocean Township.

On March 8, 2016 at approximately 0215, Officer Patrick Vaccaro effected a motor vehicle stop on Ocean Blvd. for a tinted windows offense. Further investigation revealed the occupant, Alan Fajardo, was in possession of a large amount of MDMA (also known as Ecstasy or Molly) and a smaller amount of marijuana. Officer Matt Widdis and LT Jorge Silverio arrived as backup, and Vaccaro took Fajardo into custody.

Recovered during the investigation were 1848 blue and orange pills, and under 50 grams of marijuana. Fajardo's vehicle and \$305 in cash was seized for forfeiture. He was charged with multiple drug possession charges along with several motor vehicle citations. His bail was set at \$151,000 with no 10% option by Judge Kilgallen. Officer Vaccaro should be commended for his initiative, and for once again proving how motor vehicle offenses can and often do lead to larger arrests.

PO Tracy Widdis, PO Sergio Chaparro, PO Gary Vecchione, PO Kevin Morris, PO Brian Oliveira and LT Hazel arrived as backup. Together, after a bit of a standoff, they were able to arrest all 4 individuals and locate various handguns and contraband in the residence.

These officers used tremendous restraint when facing 4 armed adversaries. They should be commended for not using deadly force, although it may have been justified in this case. Thankfully, cooler heads and training prevailed, and SGT Shamrock should be especially praised for his leadership in this crisis.

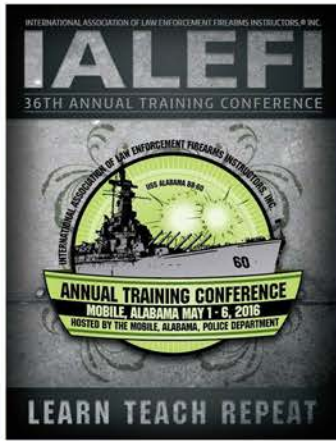

On Tuesday, 9-21-16, a little before 2AM, Officer Michael Monahan was on patrol in the City of Long Branch. He noticed what he believed to be several subjects with flashlights near an abandoned building by Westwood and Bath Avenues. Monahan, a 12 year veteran, exited his vehicle to investigate, and the subjects fled. He gave chase on foot, and apprehended one subject, before being struck on the back of his head and knocked unconscious. Responding officers were unable to reach him on the radio, and finally located him by spotting the light given off by his flashlight, which was on the ground. He was found face down and unconscious. He was transported to Jersey Shore Medical Center where he underwent observation for a head injury. We are hopeful and optimistic for a full recovery.

This is another example of the sacrifices that police officers endure daily, putting their lives in danger to protect the public. We are proud of Officer Monahan for his dedication to duty and hope he has a speedy recovery.

This is an active investigation at this point, and we are working to bring these subjects to justice. Anyone with information about this crime, please reach out to DET Joe Spitale of the Long Branch Police Department at 732-222-1000, or DET Pam Ricciardi from the Monmouth County Prosecutor's Office. Crime Stoppers is also offering a reward for up to \$5,000 for information leading to the arrest and prosecution of any suspect. The number is 1-800-671-4400. An additional \$5,000.00 was also donated by Long Branch resident, Vin Gopal, bringing the reward total to \$30,000.00.

Cpl. Sebastian "Sam" Tomaine's hard work and expertise in the Firearms field was recognized with the acceptance of his application to be an Instructor at the International Association of Law Enforcement Firearms Instructors (IALEFI) Conference. Officer Sam Yoo assisted Cpl. Tomaine at the 36th Annual Training Conference in May which was hosted by Mobile, Alabama Police Department.

The conference took place May 1st through 6th and our officers taught "Patrol Rifle Close Quarter Moving & Shooting Techniques in the Street Environment".

[Course #36.145 - 4 Hours]

The course description read:

Safely demonstrate shooting and moving techniques where "Down Range" may not be the only position to start the fight. Students will dry fire and live fire advancing to their targets from the 25 yard line in various speeds of Covert, Warrant and HRT speeds. Students will back out and shoot on command. Pivoting Drills both left and right platforms will be used. Transition drills both dry and live fire will be done with Rifle/Subgun and Handgun with duty belt."

Officers from all over United States and international law enforcement agencies from China, Italy, Hong Kong, Brazil and Taiwan attended. The class went very well with feedback that was overwhelming positive. Members of the IAFELI in charge of training have already asked them to come back to teach at next year's conference.

In addition to his many regular duties for both our Support Services Division and our Traffic Department, Lt. His expertise and dedication was instrumental in the acquisition of funds to repair the boardwalk, as well other projects throughout the City.

In total, he oversaw 10 public assistance projects, totaling approximately \$32,000,000.00. Plus, he was able to secure an additional \$11,000,000.00 (on top of the original \$24,000,000.00) to make the boardwalk even more resilient when FEMA accepted his mitigation application.

On Monday, September 5, 2016, a little after 6PM, LBPD Officers Cpl. Jennifer Gant and P.O. Christopher Walls responded to an EMS call on Myrtle Avenue. Dispatch advised the officers that there was an 8 month pregnant female that had collapsed and was unresponsive. Upon arrival, the officers were greeted by a child who directed them to the kitchen where he said, "Mommy dropped the blueberries and fell down". Neither officer could find a pulse and the female was not breathing so Cpl. Gant immediately began chest compressions and P.O. Walls spoke to the victim's boyfriend to obtain information.

MONOC arrived and began treating the woman as Cpl. Gant continued to administer CPR, administering chest compressions and providing breaths. The woman regained a heartbeat and began to take some small breaths. Cpl. Gant continued to assist with medical treatment all the way to the ambulance. Both Cpl. Gant and P.O. Walls escorted the ambulance to MMC. Thanks to Cpl. Gant's training, knowledge and swift actions, Mom and baby are recovering!

Since that call, Cpl. Gant has stayed in close contact with the family, visiting the hospital, checking on the dad and even bringing gifts to the other children in the family. As of this date, we are happy to announce that, although it will be a long road to recovery for mom, progress is being made. Baby is back home and mom is in a rehabilitation facility. And, if that isn't amazing enough, we've also learned that the baby girl was given "Jennifer" as her middle name to honor Cpl. Gant! When the dad told Cpl. Gant about this, he added, "So now you're stuck with us, your new extended family. I wanted to honor you and that was the best way I knew how."

On Saturday, August 13, 2016, Cpl. Heather Valdes responded to a flag down by a father attempting to help his unresponsive daughter. Cpl. Valdes's quick thinking and actions allowed her to save the child. The following is from a letter written by the girl's mother.

"I wanted to write in about Officer Valdes and commend her actions. Our daughter fell in the pool without her life jacket, and when we took her out, she was unresponsive and limp. We tried to do CPR, but it wasn't helping so we jumped in the car to drive to the hospital. En route, we saw a police car and my husband jumped out of our car and begged her to stop. Officer Valdes saw him, quickly got out, asked what happened and took action. She gave her two good hits to the back and a ton of water came up and she started to cry, which was music to our ears! She had me and my daughter get into her cop car, and she drove us to the hospital. I didn't know what to do while in her car because my daughter looked sleepy. She told me to rub her sternum to keep her up. Once we got to the hospital, she stayed with us to get the entire story, and showed such sympathy and I truly appreciate all she did for us. She definitely saved our daughter that day!

Later that night, she called the Pediatric Intensive Care unit where we were for the night and made sure all was ok and to check in with how our daughter was doing. Also, the following morning, I got another call and it was her again saying she just woke up and we were on her mind. The level of concern and care she expressed is above and beyond anything I expected. She truly exemplifies what a police officer should be and we couldn't be more appreciative. In a world full of police uncertainty recently due to the media, I wish we could tell our story to the world and restore some faith into how important police men and women are!

I hope you take this story to your police force, and commend her for going above and beyond for a family who needed her so badly that hot summer day! Please express our gratitude and thankfulness for her quick actions, and sympathetic nature! She is an angel in our eyes! Our family has remained complete because of her!"
